Why Give to MADACC?

MADACC was founded in 1999 to serve the animals and residents in the municipalities that comprise Milwaukee County. MADACC provides animal control services by picking up and taking in stray, abandoned, seized, injured, sick and sometimes dying animals. MADACC does their best to find owners, save the abused, heal the sick and give peace to the ones that are beyond help. While we are funded by the government to take these animals in, we are always in need of funds to care for the extraordinary medical cases we see every day.

At no time will funds be used for staffing, overhead costs, day to day animal care or anything other than costs that will directly benefit animals in need.

MADACC takes in 10,000 animals per year. Only 5% of cats go home with an owner and 30% of dogs. The rest need your help to get that second chance at adoption. Whether a simple spay/neuter, orthopedic surgery, bullet wounds, trauma from automobiles, we are always in need of more medical funds. We see extraordinary cases every day.
